## 8.9 ADD - REJECT GENERAL CONSTRUCTION CONTRACT FOR 2019-2023 CAPITAL IMPROVEMENT PROJECT PHASE 1B INCLUDING GENERAL CONSTRUCTION WORK UNDER HO-01 AT HERMAN AND OWASCO ELEMENTARY

WHEREAS, the Board of Education of the Auburn Enlarged City School District (the "Board of Education") solicited bids from prime contractors for construction services in conjunction with its 2019-2023 Capital Improvement Project Phase 1B (the "Project") including general construction work under HO-01 General Construction Contract for work at Herman and Owasco Elementary Schools (the "General Construction Work"); and

**WHEREAS,** bids for the General Construction Work were received and opened on February 25, 2021; and

**WHEREAS,** after bid opening the Project Architect and the Project Construction Manager interviewed the low bidders for the General Construction Work to confirm that the bids contained the complete scope of work described in the plans and specifications contained in the bid solicitation; and

**WHEREAS,** during the interview process it was discovered that there was confusion among the low bidders regarding responsibility for a portion of the General Construction Work which may have negatively impacted the bidding process; and

**WHEREAS,** due to the confusion among the low bidders, the Project Architect and the Project Construction Manager have recommended that all bids received for the General

Construction Work be rejected, that the description of the General Construction Work be clarified, and the General Construction Work be re-bid;

**WHEREAS,** due to the confusion among the low bidders and the recommendation of the Project Architect and the Project Construction Manager, the Board has determined that it is in the best interest of the School District to reject all bids submitted in connection with the General Construction Work received on February 25, 2021;

**WHEREAS,** the Board of Education directs the Project Architect and the Project Construction Manager to proceed with a re-specification and clarification of the General Construction Work and prepare and publish a new bid solicitation for that work in compliance with this Resolution;

**NOW THEREFORE,** the Board of Education of the Auburn Enlarged City School District upon the recommendation of the Project Architect and the Project Construction Manager, hereby resolves to reject all bids submitted in connection with the General Construction Work and:

1. authorizes its Board President, the Superintendent of Schools, or their designee to notify each bidder of the rejection of its bid in compliance with this Resolution and the bid solicitation documents and take all actions necessary or convenient on behalf of the Board of Education to reject the said bids.

2. authorizes the Project Architect and the Project Construction Manager to proceed with a respecification and clarification of the General Construction Work and prepare and publish a new bid solicitation in compliance with this Resolution.

3. Upon Board of Education approval, this Resolution shall take effect immediately.
